# Context

Representatives of TB community and CSOs who are STP CFCS implementers from EECA region, Moldova TB CAB are invited to participate in a three-days training focused on research and development, the Center for Policies and Studies (PAS Center) is convening in CHIŞINĂU, Republic of Moldova December 2-4, 2024 as part of the regional project "EECA post UNHLM community watch to leave no one behind" funded by STOP TB Partnership (STP) and with the support of COST Action ADVANCE-TB (CA21164).

# Why?

- To increase TB community and CSOs research literacy by enhancing the mobilization, coordination and research capacity.
- To inform and educate TB community and CSOs representatives about TB research globally, as well as share cases of the high-impact CLR/CBR in policy dialogue.

# What are our objectives?

- Bring together key TB community and CSOs to learn about research and trials, methods of data collection.
- Learn what steps and data is required to conduct meaningful community led and (or) based research (CLR/ and CBR).
- Discuss what data is required to support country scale up of people centered models of care, including updating diagnostic algorithms, WHO recommended treatments as well as prevention.
- Discuss how and where to use CLR/CBR results to leverage the impact these may have on policy translation
- Draft action plans for CLR research for the country in the next year or 2-3 years

### Outputs

Training module to guide TB community and CSOs on research methodology to support the use of standardised approaches and tools in conducting CLR/CBR.

Countries action plans on CLR implementation.
